Our wheelchairs cost just \$71.88 to manufacture and deliver, and are provided at absolutely no cost to the recipient. Thanks to the support of our donors, Free Wheelchair Mission was able to manufacture and ship over 14,000 wheelchairs during this three month period to those with disabilities in developing countries all over the world. Since 2001, Free Wheelchair Mission has distributed almost 700,000 wheelchairs in 88 developing countries. In the past three months, Free Wheelchair Mission donated \$426,363 of gift-in-kind medical supplies to our distribution partners. These supplies are selected to further enhance mobility to our recipients, either to augment the utility of our wheelchairs or to support surgery to prevent
