

Wheelchair Production and Distribution

For over 100 million people in developing countries, a wheelchair is either inaccessible or unaffordable. Without mobility, they must crawl on the ground, or wait to be carried to reach their basic needs. Our wheelchairs cost just \$63.94 to manufacture and deliver, and are provided at absolutely no cost to the recipient. Free Wheelchair Mission manufactured and shipped 68,285 wheelchairs to individuals with disabilities during our fiscal year ending March 31, 2012. Since 2001, Free Wheelchair Mission has distributed over 620,000 wheelchairs in 86 developing countries. Our mission is to transform lives through the gift of mobility to the physically disabled poor in developing countries as motivated by Jesus Christ.
